Alexandra Sdoukou

Alexandra Sdoukou is a lawyer and has served as a legal consultant in both the private sector and public administration. In 2007, she was formally employed by the Management Organisation Unit of Development Programmes (MOU S.A.). She holds a Law degree from Democritus University of Thrace, complemented by postgraduate degrees in European Commercial Law from the University of Bristol



and in International and European Economic Studies from the Athens University of Economics and Business.

From 2004 to 2012, she held significant advisory roles within various ministries, including the Ministries of Economy and Finance, Development and Environment, and Energy. From 2012 to 2015, she served as the Director of the Minister's Office of Environment, Energy, and Climate Change.

Her extensive expertise lies in the formulation, execution, and supervision of energy policies. Notably, from 2017 to 2019, she served as a special advisor on energy and mineral resources matters to Mr. Kyriakos Mitsotakis, the President of New Democracy Party. From July 2019 until June 2023, she held the position of Secretary General for Energy and Mineral Resources (GSEMR) at the Hellenic Ministry of Environment and Energy. On June 27, 2023, she was appointed as Deputy Minister of Environment and Energy.

Konstantinos Fragkogiannis

Konstantinos (Costas) Fragkogiannis was born in 1959, in Northern Greece (Kavala), where he completed his basic education. Following his graduation from the British Institute of Marketing (HND), he continued his studies in the U.S., earning a BS in Business Administration and an MBA in International Management & Computer Systems from the University of San Francisco.



In June 2023, his term was renewed as Deputy Minister of Foreign Affairs of the Hellenic Republic, with the portfolio of Economic Diplomacy and Openness, an office he has held since July 2019. Fragkogiannis has greatly contributed to reforms and legislation pertaining to the Ministry's restructuring on issues of economic diplomacy and the complete revamping of Enterprise Greece (Greece's Trade and Investment Agency) and Export Credit Greece. Dozens of FDIs have been supported under his leadership, while fast-track procedures, one-stop-shop services and targeted incentives have been introduced, resulting in record-breaking foreign investments and a complete turn-around in Greece's branding. Fragkogiannis has worked towards enhancing Greece's bilateral relations with Eastern Europe, the USA, Germany, all MENA countries and Libya, among others; while he also leads the 'positive agenda' initiative with Turkey. The innovative "Astypalea-smart and sustainable island" project is one of his most-known achievements at the Ministry of Foreign Affairs.

Fragkogiannis brings experience of over 30 years in the private sector, where he has held senior executive positions in major companies and groups, such as Emporiki Bank, Interbank, Delta, the Vasilakis Group, Ant1, the Viohalco Group, Vivartia, and the Chipita Group. Having successfully handled development projects worth hundreds of millions of Euro throughout the world, he has gained invaluable experience in negotiating with organizations in countries where he has overseen investments. He has led a total of 18 greenfield projects in 16 countries, 9 investment consortiums, 5 buyouts and, finally, the founding of multiple commercial enterprises in dozens of countries.

Through his many years of international experience, he has gained a wide-ranging and up-todate perspective on what is required to effectively attract foreign investments and to promote exports and growth in the globalized economy.

Στην παρούσα θητεία αξιολογήθηκε πρώτη μεταξύ των 21 Ελλήνων ευρωβουλευτών για το κοινοβουλευτικό της έργο σύμφωνα με τον δείκτη BCW, δεύτερη Ελληνίδα στην επιρροή στην Ευρωπαϊκή Ένωση και μεταξύ των 20 πιο επιδραστικών πολιτικών για το περιβάλλον στην Ένωση, σύμφωνα με το δείκτη EUmatrix. Το 2019 ανακηρύχθηκε ευρωβουλευτής της χρονιάς για την ενέργεια, την έρευνα και την καινοτομία.

Η Μαρία Σπυράκη εργάστηκε 22 χρόνια ως δημοσιογράφος. Σπούδασε χημικός στο Αριστοτέλειο Πανεπιστήμιο Θεσσαλονίκης. 
